Cold Storage Capacity Grant Opportunity Grant Period: October 2023 – September 2024

Central Texas Food Bank is excited to offer an opportunity to increase the cold storage capacity of our Partner Agencies, in support of our goal to elevate neighbor experience, increase client choice, and expand access to fresh, nutritious perishable product. This is a non-cash grant that will cover the distribution and partial installation of a cooler or freezer.

CTFB will reimburse partners up to \$1500 per unit for any electrical adjustments required for installation. Reimbursements for basic electrical adjustments for installation will only be made after the submission of original invoice to CTFB. This grant does not include any major capital/ electrical service upgrades. This will not cover ongoing maintenance or utility fees.

Due Date: Applications must be submitted via electronic form by 5pm on August 10, 2023. Incomplete or late applications will not be accepted.

Notification Date: Partner Agencies selected to receive this grant will be notified via email by August 31st, 2023.

Delivery Date: Based on vendor schedule. CTFB will place orders of the equipment in September 2023

Grant Overview

Eligible Applicants: Partner Agencies in good standing with Active status and a demonstrated need for cold storage units are eligible to apply. Cold storage support will only be awarded to PAs who are 1) currently, or will transition to a client choice model and 2) currently, or will participate in capacity-building distribution programs; 3) demonstrate desire to expand distribution days and times, no later than December 30, 2023.

Evaluation Criteria: Applications will be evaluated based on the following criteria.

- Clearly demonstrated need for cold storage units. Preference will be given for PAs who do not already have cold storage.
 - 1. Increase the agency's capacity to serve more neighbors with more fresh, perishable product.
 - 2. Enhance the agency's ability to implement client choice distribution models.
- Explanation of how cold storage award will
- Agency's ability to support the ongoing cost of the unit including maintenance and utility fees.
- Willingness to accept increased bulk loads of fresh, perishable product.

Requirements: Agencies that are awarded cold storage support through this grant agree to the following:

- Sign and return a Cold Storage Capacity Grant Agreement.
- Adhere to all restrictions or requirements laid out in the award letter.
- Complete all reporting requirements by the expressed deadlines.
- Support publicity and promotional requests by CTFB; all public communication around this grant must first be approved by CTFB.
- The PA is responsible for the unit, including damages, once it takes custody of the unit. Agencies are required to pay for a professional maintenance plan on the unit.

Reporting: Agencies will be required to submit two reports for this grant – A mid grant period report and a final report. Reporting details to follow. Grant period timeframe. Report 1: Due April 30, 2024 and Report 2: October 31, 2024

Usage: The award of a cold storage unit must be used to cover key program functions, including the PA's food distribution program, and must align with the mission and values of CTFB. The cold storage unit cannot be re-granted to any other organization, nor can it be used for personal purposes or illegal activities.
